



IMPORTANT NOTE REGARDING IJAG'S 2023 990 FOR FISCAL YEAR ENDING 6/30/2024

In the beginning of calendar year 2023, iJAG's former CEO retired after more than two decades of service. Upon her retirement, iJAG paid out a lump sum benefit from board-designated funds accumulated for that purpose over the duration of her tenure. The approach was part of a non-traditional retirement plan established by iJAG leaders early in the organization's history. No additional payments are required and no other iJAG employees are on a similar, lump-sum plan.

iJAG operates and files our 990 based on a fiscal year beginning July 1st; however, IRS rules require compensation to officers and key employees to be calculated based on total payments to the individual plus all benefits for the *calendar year in which the organization's fiscal year began*. As a result, the lump sum payment is reflected on iJAG's FY24 990, even though it was paid in the prior fiscal year.

This information provides important context for 990 Section VII and Schedule J which report employee compensation, as the combination of the lump sum retirement payment and IRS reporting requirements resulted in what might otherwise appear to be excessive compensation for a former employee.
